further to amend the Haryana Private Universities Act, 2006.

Be it enacted by the Legislature of the State of Haryana in the Sixty-first Year of the Republic of India as follows :—

1. This Act may be called the Haryana Private Universities (Second Amendment) Act, 2010. Short title.

2. In the Schedule to the Haryana Private Universities Act, 2006, after serial number 4 and entries there against, the following serial number and entries thereagainst shall be added, namely :— Amendment of schedule to Haryana Act 32 of 2006.
